

# **The West Midland Police and Crime Commissioner**



We were privileged to have the West Midland Police and Crime Commissioner, Simon Foster, address the Annual General Meeting of the West Midland Pensioners Convention held at the Birmingham and Midland Institute on Thursday April 14<sup>th</sup>.

Few would doubt the enthusiasm with which Simon Foster has taken up the

challenge of what is clearly a very demanding and responsible position as the West Midland Police and Crime Commissioner. And I'm sure we all share his concern over the impact of more than ten years of economic austerity on the funding of our regions Police Force, with cuts in the number of front-line police officers, the closure of local police stations and the virtual axing of community Police Support Officers undermining the link between our communities and those we rely on to police our streets.

A major concern for the West Midland Pensioners Convention must be Elder Abuse across the West Midland Region and particularly the degree to which the abuse of our older more vulnerable citizens has increased during the covid pandemic. A concern certainly shared by Caroline Abrahams, the Director of AGE UK who said "The Coronavirus only makes the situation worse for many at risk older people and as created another barrier to them leaving an abusive situation."

Hourglass, the older peoples Safe Guarding charity, raised their concerns in November of last year; when they reported on new analysis which revealed the "shocking" scale of the abuse of over 65s. With 1 in 5 of those surveyed (22%) either having personally experienced abuse as an older person or know someone who has been abused. Abuse and neglect, according to AGE UK, has thrived behind closed doors throughout the period of "lockdown", contributing to a sharp rise in the number of reported concerns about Elder Abuse recorded by local councils between April 2020 and March this year. In our own region, NHS Digital have released figures showing the extent of the increase in safe guarding concerns about adults with care and support needs compared to pre- covid levels; with Wolverhampton Council recording an increase of 26% from 2,670 to 3,365, Sandwell recorded a similar increase for the same period, with an increase of 11% in the number of incidents of concern reported to Walsall Council.

While The West Midland Police and Crime Plan for 2021- 2025 does identify Domestic Abuse has a Priority objective for policing across the region "Domestic abuse means that for far too many homes is not a safe place". and Simon Foster, has the West Midland Police and Crime Commissioner, to "ensure the West Midland Police priorities combating domestic abuse", - an objective I'm sure we all support, particularly in response to the high numbers of women and girls across the West Midlands facing Domestic Abuse on an almost daily basis. We have to be concerned that Elder Abuse is not, or does not appear to be an area of concern for the West Midland Police and Crime Commissioner. There is certainly no mention of Elder Abuse anywhere in the West Midland Police and Crime Plan and Simon Foster sought to reassure the delegates at our Annual General Meeting. I quote "As an older person you are less likely to be a victim of crime"

The reality is more likely to be that older victim of Domestic Abuse, whether that abuse is carried out by family members or those providing their health and care needs, are less likely to report that abuse to the Police.

## **The Crisis in the Provision of Public Toilets in the UK**



Over 600 Public Toilets across the UK have ceased being maintained by local authorities since 2010, and in 37 areas major councils no longer run any facilities. Under the provisions of Section 87 of the Public Health Act 1936, there is no Statutory Requirement for local authorities to provide public toilet facilities.

Relentless Government cuts to local authority budgets for more than ten years have resulted in the increasing closures of public toilet facilities across the UK. The reliance of local authorities on commercial and retail outlets enabling public use of their in- store toilet facilities have become severely restricted by the Covid-19 pandemic. The Covid-19 pandemic should have given all of us a stark reminder of the importance of personal hygiene in keeping ourselves and our communities safe and healthy. The provision of clean and well-maintained Public Toilets should no longer be seen as an optional extra by local authorities and by the Government as we all learn the lessons of the Covid-19 pandemic.

We call on the National Pensioners Convention to:

1). Campaign for Section 87 of the Public Health Act 1936 to be updated to make it a statutory requirement for local authorities to provide adequate public toilet facilities that are:

- Publicly owned
- Free at the point of need
- Accessible to all
- Meet statutory hygiene standards
- Protect people's safety and dignity
- Staffed by a reputable organisation or as a minimum are inspected on a regular basis.
- Signposted clearly in the local area

2). Publicise and support the British Toilet Association's call for a National Toilet Map

3). Publicise and support the campaign for "Changing Places" toilets to be installed in all public venues, so that everyone, regardless of their access needs or disability or reliance on the assistance of carers or specialist equipment, can use a hygienic toilet facility with dignity

3). All local authorities to ensure that public toilets are taken into account in need assessments of older and disabled people and in supporting their independence.

4). Campaign for local authorities to ensure that public toilets are considered in their needs assessments of older and disabled people in supporting their independence.

5). Insist that Central Government provide adequate and preferably ring- fenced funding to local authorities for the provision of public toilets

# WE DEMAND BETTER



## TUC CALL TO ACTION

The TUC has called for a national march and rally to be held in London on the 18<sup>th</sup> of June, organised under the banner of “We demand Better”. The aim of the march is to highlight and protest at the financial hardships and misery that working people are now facing on a daily basis.

The NPC Nationally has called for full support for this march, and are urging all its members across the country to attend this event, they are asking where possible for NPC branches to organise coaches but if this is not possible, to link in with local Trades Councils and Trade Union branches to secure spaces on coaches that may have been organised. This is a battle that unites both young and old, those in work and those without work, and those who are simply unable to work because of illness or disability.

We are all currently seeing a massive increase in the cost of living, with energy prices going through the roof with predicted 7% yearly rises. This means people now having to make a conscious decision about heating their home, and being able to feed themselves. We know that wages and pensions have not kept up with these increases in living costs, we have seen an attack on the triple lock for pensioners, we have seen the removal of the £20 top in universal credit for those who are living on benefits or those in lower paid jobs.

This has pushed more of our people into poverty. The Trussell Trust one of the country’s leading food charities estimate that they alone have distributed 2.1 million food parcels between April 2021 to March 2022, and a lot of these parcels are going to people in work where their wages can no longer cover living costs.

It appears that we are heading for a recession with rising levels of inflation, and that working people are going to have to pay for this crisis, the Government has already announced that they intend to get rid of 90,000 civil service jobs, they have ditched the Employment bill, which sought to improve employment rights and protection for those in low paid and zero-hour contract jobs. They have failed to protect the jobs of 800 P&O workers, opening the door for further fire and hire practices.

## **Thousands of Local Authority Buildings Still Contain Asbestos**

The TUC is calling for new legislation requiring the removal of all asbestos from public buildings following new research by the Labour Research Department, found thousands of local authority buildings including town halls, libraries and leisure centres still contains asbestos. The survey of 31 local authorities found a total of 2,690 local authority buildings, excluding schools, were found to contain asbestos; it's clear from the survey that the presents of asbestos in local authority buildings across the UK presents a substantial health and safety risk with only 10% of local authorities included in the survey.

A Freedom of Information Request has revealed that of the 191 schools Birmingham City Council is responsible for, the 161 schools constructed before the year 2,000 "have the potential" to contain asbestos. The National Education Union has reported that since 1980 at least 319 school teachers have died from mesothelioma, with 205 of those coming since 2001.

Between 1950 and 1985 asbestos was used in millions of homes, workplaces and public buildings. It is estimated that as late as 1997 there were over 3,000 asbestos products on the market, ranging from paints and tiles to brake pads and resin toilet cisterns, but the main use was either as insulation or in the form of concrete cement, which was made into products such as corrugated roofing sheets and pipes. Asbestos containing materials can still be found in around 500,000 workplaces including factories, warehouses, homes, schools, universities shops, hospitals and offices.

In 1999 legislation, The Asbestos Prohibition (Amendment) Regulations, was introduced banning the use of asbestos, with additional laws subsequently passed to regulate the safe handling of asbestos; mainly involving the safe removal of asbestos and asbestos related products; with those contracted to undertake that work required to be licenced and regulated by the Health and Safety Executive (HSE). Even so, according to the HSE own statistics, asbestos related diseases kill more people in the UK than any other single work-related cause; with more than 5,000 deaths each year. Given that it may be many years or even decades from someone being exposed to and breathing in air contaminated with asbestos dust to receiving a life-threatening diagnosis of mesothelioma; many of those now struggling with this and other diseases of the lungs and chest will now be pensioners or soon to be retirees. The Asbestos Victims Support Forum are concerned that the "current occupational data is inadequate and does not reflect the working lives of those diagnosed with Mesothelioma. The average age of someone diagnosed with Mesothelioma is 74 and sadly, following death, occupational background is not recorded for over 75s"

"It is crucial to remember Asbestos is still killing people, more than die on our roads. Asbestos Support Central England (ASCE) continues to support victims and their families and campaign to remove asbestos from public buildings."
