International Workers Memorial Day 2025



Members of the West Midlands Pensioners Convention joined our Labour Movement colleague to

Commemorate International Workers Memorial Day in the church yard at St Phillips Cathedral 28.3.25

With the State Retirement age set to increase to 67 by 2028, more and more older people are remaining in the work place into their late 60s.

For some this will be a personal choice but for many older working people, struggling to get by, working into their late 60s will be more about keeping a roof over their heads, heating their homes, and having enough of an income to be able to feed themselves and their families. The risks faced by older people in the work place have been highlighted by the Health and Safety Executive:

"In 2023/2024, workers in the UK aged 60 and over accounted for 34% of all work-related fatal injuries, despite making up only 11% of the workforce. This indicates that older workers are disproportionately at risk of fatal workplace accidents, with the rate of fatal injury increasing with age.

International Workers Memorial Day is not only the annual day when we remember those who have tragically lost their lives in the workplace but also the countless numbers of retired workers whose lives have been shortened and blighted by the conditions they faced in the workplace often many decades before.

The Health and Safety Executive have identified several key factors that go some way to explain why workers over the age of 60 account for a significant number of work-related injuries including 34% of fatal injuries in the workplace.

Factors Contributing to Higher Risk:

• Physical Changes: Age-related decline in physical abilities, such as reduced mobility and reaction time, can make older workers more vulnerable to falls and other accidents. * Musculoskeletal Disorders: Increased prevalence of musculoskeletal problems in older workers can lead to more severe injuries from workplace accidents. *Health Conditions: Older workers may be more susceptible to the effects of workplace hazards due to chronic diseases or other pre-existing health conditions. * Longer Recovery Times: Injuries sustained by older workers may require longer recovery periods, potentially leading to longer absences from work. * Increased Risk with Age: Research shows that the risk of fatal injury increases with age, with older workers experiencing higher rates of fatal injuries than younger workers.

Mike Shakespeare from the UNITE North Birmingham Community Branch



To Mike Shakespeare right is the plinth commemorating the death of two young workers who lost their lives building Birmingham Town Hall in 1834.

As a young apprentice I came across a much older electrician whose name was Billy Shaw

Billy had spent time in the merchant navy; he was also some forty years older than me.

We got talking about his time at sea. He told me of when in the 1930s he sailed from New York on a ship loaded with arms for the Spanish republican army fighting Franco. When, to get through Franco's blockades, the crew were obliged to learn fascist songs enabling them to sail through and deliver the ship's cargo and bypass the blockade.

Billy told me of another time in the merchant navy collecting cargo in the sub-continent in 1947.

Billy noticed that the Dockers there had lumps protruding from all parts of their bodies. He asked the officer in charge why and was promptly told that it was caused by the sheets of asbestos they were in the process of loading for shipment to the UK.

Some years ago, I got talking to a trade union official, for what was then the Transport and General Workers Union, the official in question tended to mainly represent plasterers, a trade that often used to lag pipes with materials containing asbestos. He told me that there was hardly a week went by when he was not attending a funeral for a past one-time union member probably for an asbestos related death.

In 2006 I was working along with three other colleagues on a job at a junior school in Aldridge. The job was to replace and rewire light fittings, all very straight forward with one major exception the ceiling was a Artex ceiling. Artex contains, albeit a small percentage of asbestos. So, when drilling into the Artex ceiling throwaway overalls masks, goggles and hats needed to be worn. Artex can be found in most offices, factories, and buildings and on building sites. When refurbishment is taking place in many a building it is almost certain that asbestos will be in situ somewhere.

Asbestos has been prevalent in many places of work where I have attended for work related reasons.

Less lucky, were my two brothers who while young men, one still in his teens, were carrying out a short-term contract in Long Acre in Nechells, both contracted asbestoses which they put down to this short-term work. Both told me the air was thick with dust and sadly no doubt had their lives shortened by that asbestos in the air.

The one thing they and I would agree on is when it comes to asbestos, then an ACCIDENTAL death is the last thing that asbestos can be attributed to. The state and the corporate world have known of the danger from asbestos for a hell of a lot longer and far pre dates its common use in the west. But despite the evidence the dangers were ignored resulting in a shorter life and often an unnecessary painful death

The West Midland Pensioners Convention is Supporting the UNITE Refuse Workers



At our Annual General Meeting members unanimously voted in favour of the following resolution supporting the Birmingham refuse workers in their ongoing and increasingly bitter dispute with the City Council. Over the withdrawal of the grade three pay grade to 150 of the refuse team who take on the additional responsibilities of ensuring the health and safety of not only their fellow crew members on the City's bin lorries but also members of

the public in what is a difficult and demanding highly physical job. With a reduction in their wages of over £8,000 annually.

The West Midlands Pensioners' Convention (WMPC) sends its full support and solidarity to the Unite refuse workers in Birmingham in their action to defend their pay, health and safety and working conditions.

We stand with you in the face of these unacceptable cuts which will impact on Unite members involved, their families and the vital service you provide to communities in Birmingham.

We recognise the difficult, essential, crucial work undertaken by you and believe you deserve to be treated with dignity and respect and fair pay.

WMPC condemns actions taken to undermine the strike and urges Birmingham City Council to recognise your concerns and enter meaningful negotiations and negotiate a fair and just settlement.

The decision to strike is never taken lightly and we commend you for standing up for what is right.

Solidarity.

The Regional Secretary of the West Midlands Pensioners Convention said of the dispute "These are skilled and responsible jobs that this council is prepared to down grade, putting members of the public and refuse workers at risk of injury and even loss of life; as sadly was the case in Coventry when a crew member was crushed to death after being caught in the loading gear on the bin wagon."

The Birmingham UNITE Refuse workers have been out on indefinite strike now for over two months with no sign of a real breakthrough with the City Council. Who, far from negotiating in good faith, declaring a "state of emergency" and Labour government Cabinet ministers, including Wess Streeting, feeding the media biased against the industrial action being taken by the UNITE refuse workers; rather than, as the General Secretary of UNITE Sharon Graham has, called for the government to intervene constructively to resolve the ongoing Dispute.

"The impact of Social Media Platforms on our lives"

In 2001/02 I was a non-executive director of an NHS Trust and for most of that period admits to taking little or no interest in personal information and data; like most members of Parliament that was my standard reaction in those days.

I do now come to this issue of personal information from a political standpoint, particularly when you look at the use of personal information in a health context. On reflection I had been involved in political campaigning for about thirty years and the methods I would use in campaigning, especially has a Member of Parliament would largely stay the same over those thirty years.

In the last ten years we have seen a generational shift in the way politics is conducted and that is a reflection in the way our society has changed because of the advent of social media platforms and the internationalisation of information and data. What happened, around 2015 the social media platforms, facebook and others, realised that they themselves were gathering huge amounts of information on individual voters. What they were in effect doing was recording individuals use of their own computers.

Going on a computer is a bit like having a parrot on your shoulder, looking at everything you search, investigate, and are interested in. All that information is recorded on a platform and may well determine what you are interested in and importantly, how you vote.

A relatively small number of people realised how valuable that information was. In the political context, it was possible to tailor messages individually to persuade them how they vote; rather what had been the case throughout my political life time of communication with people broadly with generalised messages; that is completely revolutionary in our society.

What is also important is that the platforms collecting this information are international platforms and in effect outside the jurisdiction of the United Kingdom and our Laws and Parliament. This began around 2015 at the time of the UK General Election and in 2016 with the election of Donald Trump in the US.

At this time also there was the beginning of the very large social media groups, which in my view has had a major effect on the polarisation taking place in our society at the present time. This polarisation was exploited in 2018 and exposed in the Cambridge-Analytica scandal which was using information gathered from millions of users of these social media platforms, without their knowledge or consent, for commercial gain.

The other thing that became obvious from the enquiries we conducted in 2018 was that these social media platforms were completely undemocratic and unaccountable, for example we wanted Mark Zukerman to appear before our committee and he refused to come to parliament.

Turning to health. We know that the Conservative government, before last year's general election, contracted with another company Palantir, which is a US Digital company, to gather National Health data. The subject matter of this contact with Palantir, has been largely hidden from view or open to public consultation. Subsequently we have difficulty in knowing what information is being taken, what information is being used and for what purposes. We do know that the social media platforms are exercising huge influence over the Trump administration. We have legislation in the UK which lays down some legal framework for on-line safety which we know the Trump Administration is opposed to. My fundamental concern is that we have lost control of all this information.

Adopting the policies of Reform UK will not solve the crisis in Social Care

UNIONS and campaigners have condemned Labour's immigration reforms after the Home Secretary confirmed that "We will be closing the care worker visa for overseas recruitment."

Under current rules, care workers need a certificate of sponsorship from a British employer, from which the Home Office now plans to demand more, urging them to hire locally and train domestic staff instead.

Unison general secretary Christina McAnea said "The NHS and the care sector would have collapsed long ago without the thousands of workers who have come to the UK from overseas. "Migrant health and care staff already here will now be understandably anxious about what is to happen to them. "The government must reassure these overseas workers they'll be



allowed to stay and continue with their indispensable work." "So long as care wages stay barely above the legal minimum, employers will never be able to recruit the staff needed to deliver a national care service of which we can all be proud."

She said: "The way overseas care workers have been treated by some corrupt care bosses is shameful. "Politicians must stop describing care jobs as low-skilled. They are anything but. "The work is tough, requires a high level of skills and huge amounts of empathy — as any family who's relative is receiving care support knows only too well."

Ms McAnea said that the social care sector has been in crisis for years, is severely understaffed and "unable to provide care packages for all those needing support." "That has a huge impact on the NHS too," she said. "The government must get on with making its fair pay agreement a reality and ensure social care is funded properly."



Care England chief executive Professor Martin Green described the decision as "a crushing blow to a fragile sector." "The government is kicking us while we're already down," he said. "For years, the sector has been propping itself up with dwindling resources, rising costs, and mounting vacancies." He said that "while the government had made promises of reforms under the Employment Rights Bill and a Fair Pay Agreement, those were

"years away and come with no significant funding attached." He warned of 70,000 domestic workers lost in the last two years, with vacancies still soaring. "We need proper funding, a real workforce plan, and immediate recognition that, without care, the NHS, our communities and countless families will fall apart."

Three years on!

February 1st, National Dignity Day, marks the 3rd anniversary of the NPC's campaign launched in 2021 to end the digital divide. What's the state of play? Jenny Sims reports

The Connections for All campaign was launched to address both digital inclusion and exclusion. Its twin aims are to help more older people get online and ensure those who are not, out of choice or for any reason, are not excluded – and are always offered alternative access choices to digital.

Members of the Digital Working Party (DWP) are currently updating its "A Nations Report" on the digital policies of England, Wales, Northern Ireland and Scotland, produced in autumn 2019, which included recommendations for NPC campaign actions. Its aim is to help the NPC consider its priorities for digital campaign actions, and the DWP with its workplan for the next two years.

Many reports show that too many people are still being left behind if they are not online, do not use a computer, laptop or smartphone (and cannot use Apps).

(and cannot use Apps).

To campaign successfully the NPC needs information and real-life examples from its members to use when making its case for ille examples from its members to use when maxing its case for change, whether to government e.g. over the planned closure of rail ticket offices; BT over its planned 'digital voice' switchover, or internet providers over the unaffordable costs of broadband. It needs regions to "engage" in the campaign, as the NEC agreed in 2019, which could include helping to raise awareness of the Connections for All newsletter, and its signosting information to the many opportunities nationwide - from Swansea to Southwark to set coiline.

E.g. Thanks to NPC Wales chair's influence, Swansea Council this month launched a series of digital training days and presentations for older people at the Waterfront Museum, which are being published in NPCW's own newsletter, Dragonspeech.
